IDEM Singapore would like to alert all exhibitors on a series of scams from independent organisations such as the International Fairs Directory (Inter-fairs), Expo Guide (Mexico), FairGuide.com, Mulpor Company S.R.L and its debt collecting company such as ICBM Ltd (International Business Convention Management Ltd). These scams have been recurring for several years now and many similar operations from around the world have sprung up under different names. It has been brought to our attention that companies such as Interfairs have been approaching our exhibitors directly to request for information and payment for their Fair and Exhibition guides.

We strongly advise our valued exhibitors to exercise caution when receiving such correspondence and avoid responding or making any payment. If you have been approached by any of these firms, do not complete the listings form and do not reply/return any mail acknowledging your information. *You may view a sample of the letters and forms enclosed below.*

At IDEM Singapore, we only work with our trusted partners whom we would introduce to you. Should we require exhibitors to update their information, we would ask them to do so via our Online Exhibitor Portal or appointed sales partner/sales office.

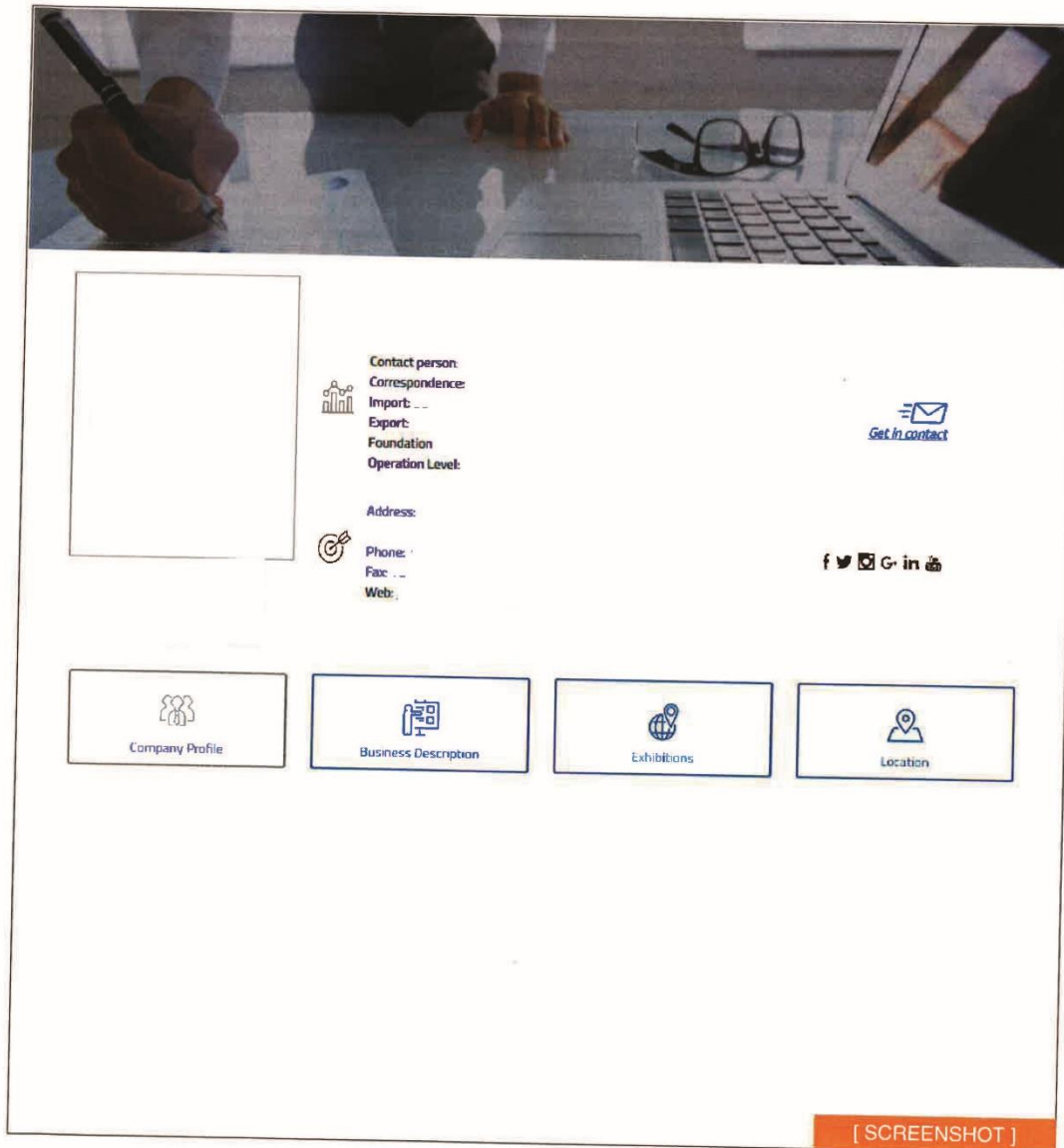
